c) Lucy Box

Councillors were asked to approve wording provided by Mrs Haxby for a new sign board to be installed adjacent to the Lucy box. The suggested wording was: 'Lucy Box' An increasingly rare survival grade II listed Victorian electrical box manufactured by Hardy and Padmore, around 1861. Commonly known as a 'Lucy Box'. The decorative styling reflects the romance and respect which was given to such infrastructure of the era. The junction box, or feeder pillar, was designed to take power from the grid and control the electrical supply to a number of buildings in the surrounding area such as workhouses and early schools.

RESOLVED: That subject to a few small revisions, the wording is approved, and research is carried out into the type and costs of potential signs.
