#### 8414 CHAIR'S REMARKS

Mrs Boyle thanked Mr Ward for his work on the response to the Local Plan consultation. Mrs Boyle reminded councillors that there could be a surgery session on 26<sup>th</sup> January including a tidy of the office.

#### 8416 GOVERNANCE

#### a) Declarations of Interest

#### b) Minutes of Previous Meeting

The minutes of the last full council meeting held on the 20<sup>th</sup> December 2018 were presented for approval.

**RESOLVED**: That the minutes are accepted as a true and complete record, and that the recommendations are approved.

#### c) Finance Notes

The clerk submitted a list of accounts, and a budget report, for November 2018, as per Appendix A.

**RESOLVED:** That the accounts are approved and payments made.

#### d) Outstanding Actions

#### e) NALC Pay Award 2019/20

Councillors were asked to approve the pay award recommended by NALC starting on 1 April 2019.

**RESOLVED:** That the Clerks' wages are increased in line with the NALC pay award from 1 April 2019: The Clerk's salary to increase from £15.54 to £15.86 per hr., and the Deputy Clerk's salary to increase from £14.22 to £14.50 per hr., both being an increase of 2%.

#### 8417 PLANNING

# a) Planning Committee 7<sup>th</sup> January 2019

#### c) Sevenoaks District Council Local Plan

Councillors were asked to confirm that they supported the response prepared by Mr Ward.

**RESOLVED:** That the agreed response is submitted to Sevenoaks District Council (see Appendix C). That a request is submitted to speak at the hearing regarding the inclusion of Pedham Place.

#### d) Planning Application SE/19/00033/HOUSE – Dunhelm, Priory Lane, Eynsford

Councillors considered an application for the demolition of the existing conservatory and the erection of a single storey rear extension with skylights.

**RESOLVED:** That no objections are offered.

#### 8418 HIGHWAYS & TRANSPORTATION

#### a) Priority Works, Riverside, Eynsford

Councillors were asked to give their views on a proposed new scheme at Riverside to solve the congestion issues around the priority areas. Kent Highways are proposing to remove top concrete build-out and wooden bollards in order to widen the road and improve visibility. They would also remove all the of the priority signs as they would be no longer necessary. This cleared section would receive double yellow lines to prohibit parking. The work would be funded by KCC and carried out this financial year.

**RESOLVED:** That councillors support this proposal.

#### b) Community Rail Partnership

Mr Richardson gave an update on a recent meeting he had attended about setting up a Community Rail Partnership for the Darent Valley. There are currently 19 stations in existing partnerships in Medway, Swale and Tonbridge areas, in Kent. The aim of the partnerships is to improve the station area, and the customer experience. Sustrans (supporting walking and sustainable transport) are also involved. The plan for the Darent Valley is to have a 'Samuel Palmer' line. The aim would be to increase use of public transport, and grow the visitor economy. Mr Richardson will share more details when they are available.

**REOLVED:** That the information is noted.

#### c) Commuter Parking, St Martin's Drive

Councillors discussed recent communication from residents about problems with double parking and blockage of access on St Martin's Drive, and whether parking restrictions would be appropriate.

**RESOLVED:** That Jeremy Clark (SDC) or Geoff Bineham (KCC) are asked to have a look at the situation and give their views on what might be possible.

# a) Community & Environment Committee 7th January 2019

## d) Darent Valley Landscape Partnership

Mr Kirby gave an update on the Darent Valley Landscape Partnership (DVLP). He confirmed that DVLP proposed to take the lead on the project south of Eynsford station that would include car parking, step-free access to Platform 1, pedestrian crossing and improvements to footpath links.

**RESOLVED:** That the information is noted.

## e) Official Unveilling, Twinning Signs

Councillors were informed that a party from our twin village of Camphin en Pevele would be isiting Eynsford in May and that an 'official unveiling' of the twinning sign (south of the station) would take place on the morning of 5<sup>th</sup> May. Any members of the council that are free were invited to attend.

**RESOLVED:** That Mr Kirby, and any other available councillors attend, at approx.. 11am on 5<sup>th</sup> May.

# f) Donation to Twinning Group

Councillors considered a request for funding from Eynsford's twinning group to fund 'official' refreshments following the unveiling of the twinning signs.

**RESOLVED:** That a donation of £200 is made to the twinning group 'Association of Camphin and Eynsford' to fund the celebratory refreshments.
